2. ECLP applications

- a. Suggestions on application process from cochairs
 - i. Some applicants had interest in accessibility but did not rank highly.
 Perhaps these applicants can be liaisons to the accessibility subcommittee if they are on a different subcommittee.
 - ii. Perhaps not use excel but have a different type of meeting document to prevent formatting issues.
 - 1. The solution can be to export a pdf document instead.
- b. Revisiting the co-chair selection role. The following are potential suggestions from co-chairs.
 - i. Could be beneficial to select existing members (however, this could lead to continuity issues)
 - ii. One year appointment with an option for a second year as a possible alternative.
 - iii. Takes a while to get used to and identify what the role is for the new co-chair. A one-year appointment may not be long enough to get used to your standing/to not overshadow the other co-chair/etc.
 - iv. At the end of your first year, you can apply to be a co-chair. If you get accepted, you stay on for two additional years (3 years total). This co-chair onboarding is only open to existing members.
 - 1. Alternative–interview for co-chair after 3 months on the committee rather than immediately. Push co-chair appointment to the end of the first quarter. By the end of March, we would then know who is going into a particular role.
 - v. Changing labels to chair and vice chair?
 - 1. Chair, vice chair, past chair
 - vi. With increased leaders, we may need to increase the cohort size to not over represent the leadership role
